locally, overseas or on-line.

The Visa International standard merchant identification codes will be used for identification of the respective spend category(for both local and overseas merchants) as per the table depicted below & DFCC will not be liable for any disputes arising due to incorrect/different merchant category codes being assigned for merchants.
